GUNSHOT PRAYERS

Vice-Postulater

Have you not often wished you could dedicate more time to prayers?

This was also a problem for Father Seelos. He was a very busy man and often longed to have more time to pray. How did he solve this problem? Father Seelos discovered a very simple but beautiful method of prayer. HE TURNED HIS WORK INTO A PRAYER. Each morning when he arose he told Almighty God that he was offering up every action of his day to Him. "O Lord, I offer all the duties of this day to You. I beg You to look upon my work as a prayer because my work is done in obedience to Your Holy Will." He repeated this intention often throughout the day. He kept his intention alive through swift but highly effective "GUNSHOT" prayers.

What is a "GUNSHOT" prayer? A "GUNSHOT" prayer is a QUICK BUT INTENSE PRAYER SAID DURING THE DAY WHILE YOU ARE BUSY DOING YOUR DAILY DUTIES. You mentally look heavenward, pull the trigger of your "praying gun" and send a quickprayer flying to God. Then you continue with what you are doing. These "GUNSHOT" prayers can be said even faster than you can fire a gun and they travel faster and farther than a bullet. Then, too, they are far more deadly than a bullet because they kill not the enemies of the body but the enemies of your soul.

You can imitate this very worthwhile practice of Father Seelos by reciting frequent "GUNSHOT" prayers.

Whenever you walk through a door or look at your watch, say: "Oh my Jesus, I love You."

When cleaning your home say: "I wish to clean my home with the same intention with which Mary cleaned her home in Nazareth."

When lighting a match think of the fire of hell and say, "Oh my God, keep my from sin in order that I may never go to hell."

When taking care of your children say a quick prayer asking the Saints in heaven to help them grow to be strong and holy Christians.

While engaged at your place of business say: "Oh my Jesus, I offer all my work to You in imitation of Your life in the carpenter shop in Nazareth."

When disturbed by an irritating or insulting person say: "Oh my Jesus, I accept this in the same spirit in which You accepted the insults of Your executioners."

In the wealth of virtues possessed by Father Seelos, courage and humility were quite evident. He was very courageous in accepting humiliations and insults and never displayed hurt feelings. Incidents related in his life demonstrate his humility, his courage.

While stationed in Pittsburgh he was called to the bedside of a dying woman who had neglected her religion. Her husband was not a Catholic and had a great hatred for priests, which probably accounted for her neglect. He was a very obstinate man and Father Seelos was warned to be on his guard against him. However, he did not he sitate for a single moment to go and minister to this poor sinner. At the sight of the priest the enraged husband rushed to Father Seelos and hit him so hard that he was bleeding rather freely. Father Seelos tried to conceal the mistreatment he had received, but some of the parishioners heard about it and wanted the offender prosecuted. Father Seelos earnestly requested that the man not be punished and through his intercession no legal action was taken against him.

After five years in charge of the major seminarians of the Redemptorist order, he was quite unexpectedly removed from his position by his Superiors. They believed that he was too lenient with the students and consequently was not the right person for this office. He accepted this removal with his usual cheerfulness. Everyone was greatly edified because they heard not the least murmur or word of dissatisfaction from him.

In successive years he served under Superiors who were much younger than he. In New Orleans he

was subject to a superior who had made his novitiate under him.

New Orleans was a most unhealthy place at the time Father Seelos was stationed there and because of his physical weakness his precious life was necessarily shortened as later events proved. However, the courage of Father Seelos could not be shaken.

His motto was "love must be crucified." He desired to see this mark on every lover of Jesus Christ. He desired all persons to be lovers of Jesus Christ. In all his sermons and conferences he spoke of his love for Jesus Christ. In all his letters he wrote of this love. It was this same "crucified love" he showed in himself from his youth until he died.

Would that we could display in our lives that same courage which Father Seelos showed when he approached the home of the dying woman. Let us with courage face our daily tasks, seeing in all our trials and in all our joys, the holy Will of God. If we are truly lovers of Jesus Christ, and everything we do is done for love of Him, we cannot help having the courage to move forward despite obstacles which may lie in our path.

"I am a widow with seven children. My husband has been dead for 17 years. One of my greatest consolations has been that all of my children have been married in the Catholic Church. I had however, one daughter who is 23 years old, who wanted to marry a boy who had been away from the Church for 17 years and did not wish to return to the Sacraments. I prayed very hard to Father Seelos and promised to help with the promotion of his cause if the boy would come back to the Church so that my daughter could be married according to the Church law.

"I am happy to say that he has now returned to the Sacraments. They were married by the priest last Saturday."

"My mother-in-law has asked me to write a letter of thanksgiving for her. She speaks French and doesn't understand English too well.

"Immediately my mother-in-law began praying to Father Seelos, asking that an amputation not be necessary, and that it would be a sign of God's power to her and restore her faith in God.
